## DIRECTIONS TO EASTLYN GOLF COURSE

### FROM PHILADELPHIA

Take Walt Whitman Bridge to Rt. 42 to Rt. 55 South to Exit #26. Continue with directions from Deptford/Pitman area.

### FROM DEPTFORD/PITMAN/GLASSBORO AREA:

Take Rt. 55 South to Exit #26. Make left onto Rt. 555 (Main Road). Then make a quick first right onto Rt. 655 (Lincoln Avenue). Continue down Lincoln to the 2<sup>nd</sup> light, turn right onto Dante Ave. Continue on Dante to first stop --- turn left --- go one block --- turn left onto Italia Avenue. We are 1/8 mile on left. (Approx. 5 miles from Rt. 55)

### FROM CAPE MAY/WILDWOOD AREA:

Take Rt. 47 to Rt. 55 North to Exit #26. Make right off ramp --- onto Rt. 555 Main Road. Continue with same directions as above. Good Sports Bar on right (corner of Panther & Italia)

### FROM OCEAN CITY/SEA ISLE/DENNISVILLE AREA:

Take Rt. 49 to Union Road (approx. ½ hour on Rt. 49). Turn right onto Union Road. (Rocky's Snack Bar on corner). Follow Union until first stop sign --- turn left onto Rt. 552 (Mays Landing Road). Continue to the third side street (Panther Road). Turn right onto Panther Road. Michaels indoor soccer is right before Panther Road. Continue on Panther to Italia Avenue. (Approximately the fifth side street on left.) Make left onto Italia (Good Sports Bar- on right). We are 1/8 mile on left.

### FROM ATLANTIC CITY/HAMILTON/EGG HARBOR/MAYS LANDING:

Follow Rt. 40 to jug handle in front of the Hamilton Mall. Stay on Rt. 40 follow thru to Mays Landing. Make left at light (Gas station at Y in road) onto Rt. 552 (Bears Head Road/Mays Landing Road --- Precision Auto on right.) Continue on Rt. 552 (Mays Landing Road) --- Over the railroad tracks (4 way stop) approx. 3 to 4 miles, turn right onto Panther Road. Michaels Indoor Soccer is right before Panther Road. Continue on Panther Road to Italia Avenue. (Approx. the fifth side street on left). Make left onto Italia (Good Sports Bar on right). We are approx. 1/8 on left.

### FROM EGG HARBOR CITY:

Take Rt. 50 to Rt. 40 --- follow directions above from Mays Landing area.

### FROM BERLIN AREA:

Rt. 42 to Cross Keys intersection, continue onto Rt. 555 (Main Road) (Cross Keys airport on the right.) At light bear to the right, Rt. 555 continues on. Continue on Rt. 555 to Chestnut Avenue (in Vineland). Make left onto Lincoln (3<sup>rd</sup> traffic light after onto Chestnut). Then make first left onto Menantico Road. Make a right at Venezia Avenue. (First right) Go around bend -- we are approx. 1/8 mile on right.

### FROM DELAWARE MEMORIAL BRIDGE:

Take Rt. 40 to Rt. 55 to Exit #26. Follow the rest of the directions as if coming from Walt Whitman Bridge.
